### Steps for Joining USCSS<sup>TM</sup>, Registering Dog and Entering this Trial:

- 1. All competitors must become a member of  $USCSS^{m}$ , which is free. Competitors may join here: http://members.uscaninescentsports.com/signup.
- 2. Competitors must then register their dog(s) through the USCSS™ website. Each registration includes a one-time \$25.00 fee. Competitors may register their dogs here: http://members.uscaninescentsports.com/login?redirectTo=http://members.uscan inescentsports.com/dog/register
- 3. When logged into their account on the USCSS $^{\text{m}}$  website, competitors may then scroll down to the "LOCAL EVENTS" section, find the trial they are interested in entering and click on the ENTER button.
- 4. Competitors may then select which dog they are entering and select which Classes and/or Games they are entering.
- 5. Competitors will then receive a confirmation email with details regarding their entry and instructions on how to submit payment for their entry. All payments will be sent directly to the trial host, not  $USCSS^{TM}$ . The confirmation email will specify how payment will be made (e.g. via PayPal, mailed check, etc.). Competitors should note that their spot in the trial will only be held once payment is made.

#### **VOLUNTEERS NEEDED:**

### **SCHEDULE:**

4:45 pm - Dog in White

5:00 pm - Trial is open - dogs will run in order of sign-up upon arrival.

You do not have to arrive at 5:00 pm! You may arrive any time between 5:00 pm - 7:00 pm, and you will be able to sign up and run your dog(s).

<u>PARKING</u>: You will be directed where to park, parking is in a dirt lot with no shade - prepare accordingly.

NO SMOKING: No smoking ANYWHERE on the grounds. Vaping is ok.

<u>SAFETY, COLLARS & LEASHES:</u> Flexi/retractable leashes are only permitted during a search. All dogs must be on a 6' or shorter leash when not participating in a search. Dogs MUST be switched over to a 6' length or shorter leash when outside of the search area. Choke chains, prong collars or halti/head collars are not permitted during searches. Leashes of any length may be used while the dog is participating in a search. EVERY dog MUST maintain a minimum of 6' distance from all other dogs at ALL TIMES.





<u>PAYMENTS & WAIVERS:</u> Please sign the attached waiver and bring to the trial. Payment through Venmo to @Jinny-Chow or by check payable to Jinny Chow.

<u>REFUNDS & EVENT CANCELLATION</u>: Every attempt will be made to hold this event as scheduled. We will make every attempt to contact entrants and inform them of cancellation or postponement.

Dogs must have valid  $USCSS^{m}$  registration numbers to compete in this trial. Handler may run multiple dogs, but titling dog must be run first.
